#### **California Budget Crisis:**

### **Governor's Medi-Cal, Mental Health Budget Proposals Focus of Senate Budget Committee Wednesday – Controversial Proposal to Renew and Expand Medi-Cal Quality Assurance Nursing Home Provider Fee Also on Agenda**

***Assembly Budget Subcommittee on Health & Human Services Also Scheduled to Meet At Same Time Though Mostly "For Vote Only" Items – Controversial Proposal to Extend and Expand Medi-Cal Quality Assurance Nursing Home Provider Fee Will Likely Be Heard In Assembly on Thursday***

SACRAMENTO, CALIF (CDCAN) [Updated 05/25/2010 11:10 PM (Pacific Time)] - Several controversial budget proposals by the Governor will be the focus of the full Senate Budget and Fiscal Review Committee and the Assembly Budget Subcommittee #1 on Health and Human Services when they hold separate hearings Wednesday morning (May 26<sup>th</sup>) at nearly the same time. Both houses are moving quickly this week to close out this phase of the state budget process. This is the final week of budget subcommittee hearings – though the Senate Budget and Fiscal Review Committee is meeting and taking final action instead of its 5 subcommittees this week

Due to the size of the agendas for both hearings (the Senate Budget and Fiscal Review Committee agenda is 71 pages and the combined length of the 2 part agenda for the Assembly Budget Subcommittee on Health and Human Services is 76 pages. Both houses of the Legislature have held and scheduled their final budget subcommittee hearings Wednesday and Thursday this week, taking final action on several of the Governor's major proposals impacting people with disabilities, mental health needs, the blind, seniors and their families, before the budget process heads to the next phase of "budget conference committee" hearings in early June.

## **Senate Budget Committee Hearing Likely Will Draw More Attention With Several Controversial Issues on Agenda**

Of the two hearings on Thursday morning, the Senate Budget and Fiscal Review Committee hearing is likely to be longer and more important in terms of attendance by the public because it is taking up budget issues proposed by the Governor as part of his May 14<sup>th</sup> budget revisions that this committee has not yet heard before.

The public will have an opportunity –as it did Tuesday before this same committee, to provide brief public testimony on these issues that focus largely on Medi-Cal and Mental Health proposed reductions, in addition to one “for vote only” item relating to increasing from 3% to 4.25% beginning July 1, 2010 through June 30,2010 a reduction in payments for most regional center providers and to regional center operations.

## **Controversial Proposal to Extend and Expand Quality Assurance Fee For Nursing Homes on Senate Committee Agenda**

- A controversial proposal by the Schwarzenegger Administration to extend and expand the Quality Assurance Fee for nursing homes that imposes a provider “tax” that is matched by federal Medicaid funds that in turn is partially given back to the provider in the form of higher reimbursement rate is on the May 26<sup>th</sup> Senate Budget and Fiscal Review Committee agenda – though it is listed after many other controversial items that will be heard first. The State retains part of that increased funding that comes back to the State to help pay for other State general fund expenses.
- This issue is referred to sometimes as the “AB 1629 Reauthorization” – named after the bill that first authorized it in 2004.
- The proposal was controversial then and now, with disability and some senior advocates deeply concerned or in opposition to the proposal because they have claimed the State has not done a good job in oversight to make sure nursing homes who received the increased reimbursement rate improved quality of care in addition to passing on the increased funding to their workers. Some nursing home providers raised concerns with some of the new proposed measures to improve oversight and limit how the increased funding can be used.
- A 3 page fact sheet on the proposal by the Department of Health Care Services – released last week, is attached to this CDCAN Report and also can be viewed from the CDCAN website at [www.cdcan.us](http://www.cdcan.us)
- The issue will likely be heard in the Assembly Budget Subcommittee #1 on Health and Human Services on Thursday (May 27).
- The issue directly impacts people with disabilities, mental health needs, seniors and others and their families in the nursing facilities that qualify for this Quality Assurance Nursing Home provider fee; impacts the workers in those facilities; the providers/owners of those facilities.
- It also has impact on the State’s implementation and compliance of the 1999 US Supreme Court “Olmstead Decision” under the federal Americans With Disabilities Act (ADA). That decision required the states to take steps to avoid the unnecessary or unjustified institutionalization of persons with disabilities, mental health needs and seniors.

### **Proposed Closure of Lanterman Developmental Center on Assembly Subcommittee Agenda – But Not On Senate Committee Agenda**

- The proposed closure of Lanterman Developmental Center in Pomona, was previously heard and public testimony taken by both the Senate and Assembly budget subcommittees in late April and early May.
- While both subcommittees approved some budget related legislative language (referred to as budget “trailer bills” because the bills follow or trail the main budget bill, making necessary additions or changes to state law as needed) neither subcommittee has yet given final approval of the actual closure plan that the Governor submitted to the Legislature on April 1<sup>st</sup>.
- The proposed closure of Lanterman Developmental Center is a “for vote only” item as part of the Assembly Budget Subcommittee hearing agenda (along with several other items under the Department of Developmental Services, the state agency that oversees the operations of the state owned and staffed developmental centers – and contracts with 21 non-profit regional centers to coordinate community-based services to over 240,000 children and adults with developmental disabilities).
- The proposed closure of Lanterman Developmental Center however is not on the Senate Budget and Fiscal Review Committee agenda for Wednesday. That agenda has only one item dealing with developmental services – a “for vote only” item that is the Governor’s proposal to increase the payment reduction to most regional center providers and operations from 3% to 4.25%. No other developmental services budget item is on the May 26<sup>th</sup> agenda. The same committee is scheduled to hold its last hearing during this budget subcommittee phase of the budget process on Thursday. After that the budget process moves to the budget “conference committee” phase.
- If the proposed closure of Lanterman Developmental Center is not taken up by the Senate Budget and Fiscal Review Committee Thursday, then it will likely be an issue that will be considered by the budget conference committee, which likely will begin its hearings in early June through mid-June. No public testimony is taken at these hearings – though all meetings are public and televised.

### **State Senate Full Budget Panel Will Meet Instead of Subcommittees**

- May 26<sup>th</sup> - On Wednesday the full Senate budget panel will meet to hear health related budget issues including 1 developmental services (“for vote only”) issue and discuss and take public testimony and possibly take final action on several budget proposals by the Governor impacting cuts to Medi-Cal, the proposal to expand and extend the Medi-Cal Quality Assurance Fee for nursing homes, cuts to Mental Health, Healthy Families, Public Health.
- May 27<sup>th</sup> - It will hold what will likely be its final hearing to close out the Senate budget subcommittee phase of the budget process on Thursday (May 27) focusing on education issues.

### **Assembly Budget Subcommittees Will Meet This Week To Take Final Action**

- May 26<sup>th</sup> - In the Assembly, its five budget subcommittees held hearings last week and took several final actions and will be holding their final hearings on Wednesday (May 26<sup>th</sup>). The hearing on Wednesday will largely be “for vote only” for a number

of the Governor's proposals including those impacting IHSS, Cash Assistance Program for Immigrants (CAPI), CalWORKS, regional centers and the proposed closure of Lanterman Developmental Center.

- May 27<sup>th</sup> – Assembly Budget Subcommittee on Health and Human Services is scheduled to meet at 09:00 AM cover any “open” budget items that it has not yet taken action on. The subcommittee might possibly take up the proposal by the Schwarzenegger Administration that calls for expanding and extending the Medi-Cal Quality Assurance Fee for nursing homes. Advocates and even some nursing home providers have raised different concerns and problems regarding the proposal. This will likely be the final hearing of this subcommittee.

### **Actions by Both Houses Not Final**

Actions by both the Senate and Assembly budget subcommittees – or full budget committees are not final however. Actions by both subcommittees or budget committees at this stage – especially if both agree, however does send a strong signal about the position of the Legislature on a particular proposal by the Governor.

The process heads to the next phase – the budget conference committee (a joint committee of 6 members, 3 from each house) to work out any different actions that either house took. That phase lasts through most of June – and then the budget process goes to the Assembly and Senate floor, where it will likely remain until a budget agreement is reached with the Governor and the legislative leaders. A long budget stand-off, given the enormity of the budget deficit, is seen as certain, to probably last through the summer.

### **MAY 26<sup>TH</sup> SUMMARY OF ASSEMBLY BUDGET SUBCOMMITTEE #1 ON HEALTH & HUMAN SERVICES AGENDA**

The subcommittee will conduct its hearing on Wednesday with the hearing agenda divided into two parts:

- Part 1 (24 pages long) will focus on “for vote only” budget items dealing with the Department of Developmental Services (normally additional public testimony is not taken on those items since all have been previously heard). There are no “items for discussion” on this agenda (meaning new items not previously heard).
- Part 2 the second part deals with human services budget issues contains “for vote only” items including proposals by the Governor to eliminate the entire CalWORKS program, proposals for major cuts to IHSS, Cash Assistance Program for Immigrants and more. All of those items were previously heard and normally additional public testimony is not taken on those items. Following the long “for vote only” items are “items for discussion” – meaning public testimony will be taken, on 5 budget items.
- Items highlighted in **RED** and with three \*\*\* (for sight impaired or persons who are blind) are budget issues that are controversial or of special interest to people with disabilities, mental health needs, the blind, seniors, their families and others.
